2024 was a remarkable year for River Hospital. As a small critical access hospital, we remain committed to evolving and growing in response to the needs of the community. One highlight was the launch of a nationally recognized employee appreciation program. Under the guidance of our dedicated Board of Directors we are preparing to break ground on the next phase of River Hospital's transformation. Thanks to a \$10.7 million grant from the New York State Department of Health, we are set to modernize our

inpatient unit, introduce a new dining area for staff and families, create a dedicated space for employees and providers, and make enhancements to our imaging department. This progress is the result of proactive planning and timely submissions to New York State, led by our senior leadership team, and supported by the vision of our Board.

River Hospital's impact is strengthened by the unwavering generosity of our donors and the community. Your support provides critical funding for equipment and facility upgrades, provides invaluable feedback and insight, and fuels engagement for community education and events. We are also making significant strides toward our endowment goal. A recent major gift brings us to 60% of our target—an investment that will help secure the future of River Hospital for generations to come.

With a refreshed strategic plan, River Hospital is looking ahead to 2025 with a focus on service expansion and excellence in care. Our path forward includes a fully staffed primary care team, continued access to high-quality specialty care, the addition of both pulmonology and ENT services, and a commitment to patient-centered care, modern facilities, and community partnerships.

We are proud to continue our commitment to the delivery of high-quality rural healthcare in the North Country—providing compassionate, expert care close to home. Thank you for being a part of our story and our future.

Building the Future OF CARE

In the Spring of 2024, River Hospital was notified that it was awarded a \$10.7 million dollar grant from New York State's Statewide Health Care Facility Transformation Program. The program is administered by the New York State Department of Health and the Dormitory Authority of the State of New York. Its goal is to improve patient care by supporting high-quality facilities serving the inpatient, primary care, mental health, substance use disorder and long-term care needs of communities throughout the state. The award will be used to support hospital capital improvements, to upgrade existing infrastructure, and to accommodate program growth.

This project focuses on ensuring those in the local community have access to exceptional healthcare, close to home, while maximizing critical and limited inpatient resources within our system of care. Our goal is to finish modernizing the space and to create additional square foot capacity for the inpatient rooms to meet updated healthcare facility


guidelines, which will reduce the bed capacity within the existing inpatient footprint. Even though the transformation will reduce our current number of licensed beds from 22 to 17, based on census data collected, we do not anticipate any adverse changes in access to the inpatient services we provide or the number of staff we employ as a result of this project.

The benefits of this project will properly align with more appropriately sized inpatient rooms, including improved accommodations, showers for each room, adding negative pressure/isolation capabilities to

address the increased demand for caring for patients with infectious disease, improving ability to care for handicapped and bariatric-size patients, refining accommodations for sub-acute rehabilitation patients who remain for longer stays, and providing a more efficient floor plan which will mean improved workflows and enhanced patient care. Our facility will also benefit from an updated technology infrastructure for patient rooms that supports a nurse call and patient notification system, and will improve patient, staff, and visitor safety. In addition, the lower level of the hospital will be modernized to support services and improve patient flow in the imaging department.

Expansion of SPECIALTY CARE

River Hospital has made significant strides to address critical specialty health care gaps. This includes the expansion of our orthopedic services through a partnership with Samaritan Medical Center, and the addition of a Pulmonologist, Frederic Seifer, MD.

Brian Zafonte, MD works alongside River Hospital's orthopedic team to provide office visits and perform outpatient surgeries. The partnership began in mid-2024 as a pilot program and has proven beneficial to patients by allowing for continued growth, additional appointments, and more surgical options. This opportunity allows us to expand our offering for high-quality, efficient orthopedic care to the communities we serve, and by partnering with Samaritan, we are able to evolve and augment our current offerings.



Frederic Seifer, MD

Frederic Seifer, MD, board-certified Internist and Pulmonologist joined the River Hospital medical staff to provide outpatient pulmonary care to residents of the North Country. Dr. Seifer has extensive knowledge and unrivaled expertise in pulmonary care and internal medicine. With over 40 years of experience in the medical management of chronic diseases, he diagnoses and treats conditions of the chest, such as bronchitis, pneumonia, asthma, COPD, emphysema, bronchiectasis, and other complicated infections or tumors of the chest. Dr. Seifer also offers expertise in smoking cessation.









River Hospital Launches DAISY AND BEE AWARDS



Celebrating Our Healthcare Heroes

To honor and celebrate compassionate care, River Hospital launched the DAISY and BEE Awards in the Spring of 2024. Nominated by patients or colleagues, two employees are selected bi-annually, and honored for displaying exceptional care to patients. Kelly Smith, RN and River Hospital Care Coordinator is the recipient of the first DAISY Award, and Mattilynne Hough, Patient Registration Clerk was the first to be awarded our BEE Award.

The DAISY Award is an international award program by The DAISY Foundation. An acronym for Diseases Attacking the Immune System, The DAISY Foundation was formed in November 1999, by the family of J. Patrick Barnes, who died at age 33 of complications of Idiopathic Thrombocytopenic Purpura (ITP). The nursing care Patrick received when hospitalized profoundly touched his family and inspired them to express gratitude to nurses with programs that recognize them for the extraordinary compassionate, skillful care they provide patients and families. DAISY honorees receive special benefits to advance their nursing careers, including reduced tuition, conference scholarships, special rates on certification, and more.

The BEE Award stands for “Being Exceptional Everyday” and was established to recognize non-nursing patient care partners who go beyond extraordinary expectations.

River Hospital Earns 2024 Performance Leadership Award *From the Chartis Center for Rural Health*

As part of National Rural Health Day, River Hospital earned a 2024 Performance Leadership Award for excellence in Patient Perspective. Compiled by The Chartis Center for Rural Health, the Performance Leadership Awards recognize top quartile performance (i.e., 75th percentile or above) among rural hospitals in Quality, Outcomes and/or Patient Perspective.

The Performance Leadership Awards are based on the results of the Chartis Rural Hospital Performance INDEX®, a comprehensive and objective framework for assessing how rural hospitals are performing. INDEX benchmarks are relied upon by rural hospitals, health

systems with rural footprints, hospital associations, and state offices of rural health to measure performance across multiple areas impacting hospital operations and finance.
