2018 will be an exciting year for River Hospital. We will begin the renovation of the Monticello for our new Medical Office Building this spring and we will begin the major renovations to the main Hospital this summer. These major undertakings have been made possible by a New York State grant and a very successful Capital Campaign which so far has raised over \$3 million dollars.

Already we've had great success this year with very positive financial results and we are optimistic that our strategic planning which has enabled us to achieve and maintain financial sustainability will continue to solidify our place as a vital health care resource to our community.

2018 also marks the year that River Hospital turns 15 years old. Few outsiders would have believed that this small struggling institution that was barely surviving when it became independent in 2003 would not only survive but would flourish to become what it is today – a strong vibrant Hospital that is successfully preparing for the future through new services, facilities and partnerships.

The River Hospital success story is a story of community commitment: the commitment of the community to preserve and sustain the Hospital; and the Hospital's commitment to serve the community.

The Hospital's commitment to the community is reflected every day through the extraordinary dedication of our employees who have always done whatever they could do to carry out the mission of the Hospital. And the Hospital's commitment to the community is also demonstrated by our Board of Directors who have shepherded this institution through innumerable challenges to now emerge as a solid and valuable community asset ready to tackle the future challenges of health care on behalf of our communities.

This is a special year in that we can look back with pride and appreciation for what has been accomplished; and we can look forward with excitement and genuine optimism to a very bright future.

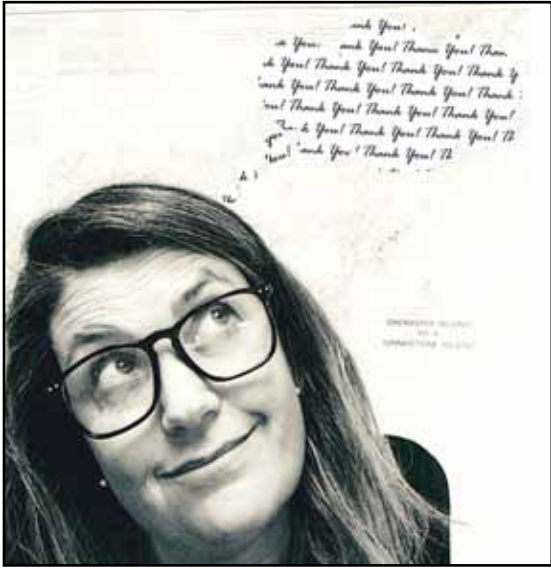

# Remembering Richard R. and Mary Macsherry

The end of 2017 Summer brought news from Florida of the passing of Richard R. Macsherry. Though his 99th year, “Dick” Macsherry was a robust, gregarious figure who delighted in giving back to the North Country, particularly to his beloved Thousand Islands.

He was known to freely explain, “I came back from the war in the Pacific to find good business opportunities and a fine area to raise my family. Giving back became a family expectation”. Mary Macsherry, Dick’s wife of 64 years, was also a passionate philanthropist. She died in 2012 at the age of 94.

Dick and Mary’s families had maintained an annual Summer presence in the Alexandria Bay area dating back four generations. As Dick gained success in the trucking industry he began donating time, energy and money to local charities and service organizations, including the United Way, Salvation Army, The United States Power Squadron, Rotary and the Chamber of Commerce. For her part, Mary maintained a dedicated delivery route with Meals On Wheels and volunteered hundreds of hours to the House of Good Samaritan Auxiliary.

Dick divested his business ownerships in 1980 and approached philanthropy with an accelerated vigor. His interests were varied and included the Antique Boat Museum, the Thousand Islands Land Trust, the Clayton Opera House and Thousand Islands Emergency Services in Clayton, the Cornwall Brothers Museum, the Macsherry Library, which Mary and Dick built and dedicated in 1997, Church of St. Lawrence in Alexandria Bay and the Macsherry Trail at the Crooked Creek Preserve in Hammond.

The last two decades of Dick and Mary’s lives saw many instances where River Hospital became the area of first response to an array of health issues. In recognition of River Emergency Services Department, Richard donated \$1 million to upgrades made in 2012 in honor of Mary. That was followed by 2015 with a donation of a new elevator and a project cost of more than \$450,000. Finally, as a kick off to River Hospital’s Hope + Healing Capital Campaign Dick made a final contribution of \$1 million on behalf of the Macsherry Family.

River Hospital is eternally grateful to the Macsherry family for their generosity and vision, both here at the Hospital, and through our the greater community.

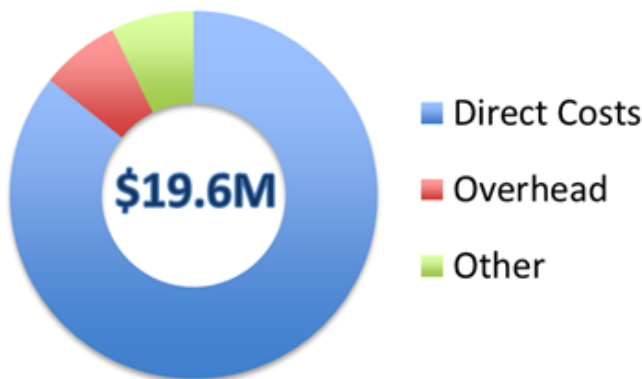
2016 Volumes



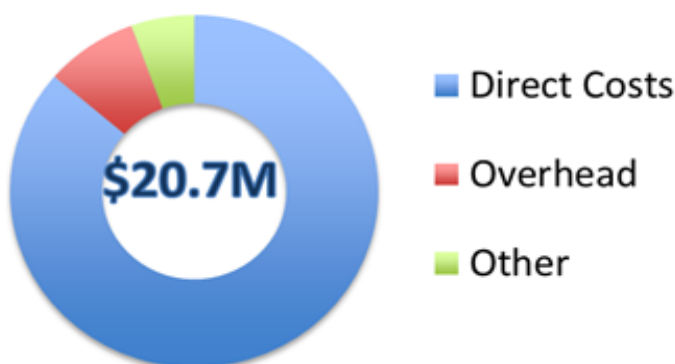

## New Partnership connects River Hospital with Syracuse-based Crouse Health

The Boards of Directors of River Hospital, Carthage Area Hospital, Claxton-Hepburn Medical Center, and Crouse Health have announced clinical affiliations to enhance health care quality and access in Central and Northern New York. Through the affiliations, patients will gain access to specialized care and physicians throughout Central and Northern New York. They will be able to see specialists from the hospitals participating in the agreement when needed, either in the hospital, in physicians' offices or through advanced telemedicine, which will be supported through Crouse Health's affiliation with Northwell Health. "This partnership will provide our patients access to a whole new level of specialized care. With the ability to access physicians at partner institutions and the availability of advanced telemedicine supported through Crouse Health's affiliation with Northwell Health, our patients and neighbors will receive an unprecedented level of comprehensive and compassionate care through a trusted local institution," Ben Moore, River Hospital CEO.

## River Community Wellness Program now treating Veterans with PTS

In 2017, River Hospital was given approval from the Department of Veteran Affairs to treat veterans with post-traumatic stress. The River Community Wellness Program has provided off-post, intensive therapy to active-duty soldiers since 2013. Since last September, over 40 Veterans have come through the program. "While the VA does the best it can do, some vets need more than they can offer. We have what is needed and know how to provide it," Brad Frey, Director of the River Community Wellness Program. You may not always be able to see them, but the effects of post-traumatic stress are very real. In fact, they can be even more dangerous than the wounds you can see. Now that River Hospital's Veterans' PTS Program makes it easier to use VA Benefits, affordable and confidential help is close to home.

## 3-D Mammography is coming to River Hospital this May

Patients at River Hospital will be able to take advantage of the most advanced technology in imaging. A breakthrough in breast cancer diagnosis, 3-D mammography, delivers a clearer view of the breast tissue than traditional mammography alone, allowing radiologists to detect small tumors at their earliest and most treatable stages. This powerful tool is just one of the ways that River Hospital is helping patients take control of their health and better their odds in the fight against breast cancer. Pink ribbons and fundraising walks offer steady reminders that the risk of breast cancer is real-and that is it treatable and survivable. The key is screening and early detection. # Plans for Tomorrow's River Hospital: The Hope + Healing Capital Campaign

River Hospital's Hope + Healing Capital Campaign will support the renovation and restoration of the existing hospital building, as well as the historic Monticello building across the street which will be converted into a medical office building. The medical office building will house integrated Primary and Behavioral Care, as well as Physical Therapy and administrative services. Plans for Hospital improvements include the following critical components:

Medical Office Building space will be created in the Historic Monticello Building to house primary care, behavioral health, physical therapy, administration and financial support services. This will physically integrate primary care and behavioral health, which is essential to effective health care delivery. This will also provide a long term solution to the outdated temporary modular structures which currently houses the primary care and specialty providers. The existing Physical Therapy services are located within the main hospital, and are very spatially restricted as well, with no more room to expand. Physical Therapy is a highly utilized service line and will be relocated to a larger space with increased privacy in the rebuilt Monticello Building.

Main hospital modernization and renovation will include significant upgrades to emergency services, reception and waiting, and will expand the Emergency Department and enhance its configuration to improve patient flow and staff efficiency. Upgrades to the Ambulatory Surgical Unit (ASU) will include a second operating room located on the second floor of the facility. This addition will greatly improve operational and functional efficiency for the surgeons, staff and patient flow over the current single room design. The new plans will also co-locate radiology, laboratory and cardiopulmonary services to improve efficiencies, especially in the cases of emergency services. Finally, the project will provide necessary upgrades to the existing hospital facility and provide funding for capital purchases and equipment purchases to stay current with ongoing technology and quality patient care.
